RNM - WHAT IS THIS DOCUMENT?

The National Migration Registry (**Registro Nacional Migratório** - acronym: **RNM**) is the registration number of each immigrant in Brazilian territory. It is mandatory for all immigrants holding a temporary visa.

Formerly, the RNM was called **RNE** - National Registry of Foreigners.


The responsible for the RNM is the Federal Police (PF) of Brazil.



RNM - WHAT IS THE DEADLINE?

The deadline to regularize is **90 days** after entering Brazilian national territory. Therefore, pay attention to the dates, once the 90-day limit is exceeded, the applicant will have to pay a fine for each day of delay.

If you stay in Brazil **for less than 90 days**, it is not necessary to apply for the RNM.



RNM - REQUIRED DOCUMENTS (STUDY VISA HOLDERS)

PART 1

Application PF's form completed and signed.

The applicant must bring the **printed version**, which must contain the **QR Code** and be signed at the bottom of the page by the applicant

RNM - REQUIRED DOCUMENTS (STUDY VISA HOLDERS)

PART 2

Proof of payment of the fee for issuance of CRNM (National Migration Registration Card)

How to do:

The applicant should go the link and fill in with your personal details to generate the GRU (Guide for Collection of Fee).

The applicant must pay this fee in cash at any bank branch.

PART 3

How to do:

This Declaration must be done by hand and in block letters

PART 4

2 (two) pictures 3x4 size

How to do:

- It needs to be recent, colorful, white background on photographic paper;
- In São Paulo there are several establishments that offer this service. We recommend looking around the Butantã Metro or at Shopping Eldorado.



RNM - REQUIRED DOCUMENTS (STUDY VISA HOLDERS)

PART 5

Valid Travel Document (Passport).

In addition to your original Passport, have a **physical (printed) copy** of the Passport (and all pages, including blank pages) too;



RNM - REQUIRED DOCUMENTS (STUDY VISA HOLDERS)

PART 6

Visa form

The original visa form, and attention, it must be signed in the field "Disclaimer"



RNM - APPOINTMENT AT PF (STUDY VISA HOLDERS)

Make an appointment at the Federal Police (PF)

After providing **all the requested documents**, the student must schedule a day and time at the Federal Police agency to take the documents and register as an immigrant (RNM).

BY USP

Make an appointment at the Federal Police (PF)

If the student wants to, USP has a partnership with the Federal Police and students can request the appointment via the FAU International Office.

Make an appointment at the Federal Police (PF)

The student must send **all scanned documents** via email to:
incoming.fau@usp.br AND international.fau@usp.br

The documents should be sent in a **single PDF file**

At our webpage we offer a **check-list**.

In the absence of a document, the request will not be processed.



RNM - APPOINTMENT AT PF (STUDY VISA HOLDERS)

BY USP

Make an appointment at the Federal Police (PF)

After sending the documents, the student must wait for a response from the USP Rectory (AUCANI) informing the day and time of the appointment.

RNM - DATA UPDATE AT USP (STUDY VISA HOLDERS)

After the student has their RNM, we ask them to send us the following information by email:

RNM number

(this information appears in the protocol issued on the day of the scheduled interview)

Date of issue

(usually the date of the PF interview)



OTHER CASES

- **Brazilians (born or naturalized): do not need RNM**
- **In other cases of immigrants who do not have a student visa, we recommend that you look directly on the Federal Police website for the list of documents required to register.**
